Unlabelled vials could potentially result in product being used for unintended purposes. However, vials without labels are easy to identify immediately. If the vial is labelled, there is no risk, and the product does not need to be returned.

What to do if in possession of this chemical product

Veterinary wholesalers and end users should check all stock on hand of batch 241057A for affected units (i.e. unlabelled vials). If any unlabelled vials are found, please isolate the product and place in quarantine. Troy (contact details included below) will provide advice on management of affected units and arrangements for replacement.
