Australian Pesticides and Veterinary Medicines Authority

The Agricultural and Veterinary Chemical Code Act 1994 (the Act) commenced on 15 March 1995. The Agricultural and Veterinary Chemicals Code (the Agvet Code) scheduled to the Act requires notices to be published in the *Gazette* containing details of the registration of agricultural and veterinary chemical products and other approvals granted by the Australian Pesticides and Veterinary Medicines Authority. The Agvet Code and related legislation also requires certain other notices to be published in the *Gazette*. A reference to Agvet Codes in this publication is a reference to the Agvet Code in each state and territory jurisdiction.

On 7 July 2025, Boehringer-Ingelheim Animal Health Australia Pty Ltd (ABN 53 071 187 285) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

Reason for voluntary recall

The voluntary recall for batch 3254005 has been initiated due to trend data from routine stability monitoring that indicated this batch may not remain within the potency specification for Feline Calicivirus (FCV) for the duration of the shelf-life period. The recall is limited to batch 3254005 only.

Hazard

There is low hazard associated with this batch recall as this batch currently remains within its potency specification. Therefore, for animals vaccinated with this batch to date, there should be no impact on product safety or efficacy. This is a precautionary and proactive action only.

What to do if in possession of this chemical product

Veterinary clinics will be contacted to return any remaining inventory of batch 3254005 to their veterinary wholesaler. There is no action required to be taken by pet owners.

On 7 July 2025, Troy Laboratories Pty Ltd (ABN: 000 283 769) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

Reason for voluntary recall

Over the shelf life of the product, the active ingredient was found to be below specification for batches 230915A and 24061DA.

Hazard

The defect may result in reduced efficacy.

What to do if in possession of this chemical product

Cease use immediately and contact your supplier.

On 8 July 2025, Headway Investments Pty Ltd (ABN 91 655 095 855) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

Reason for voluntary recall

The active constituent statement on the common leaflet has a typographical error and incorrectly states 0.5 mg/mL of meloxicam rather than 1.5 mg/mL of meloxicam.

The immediate label and primary label are not affected and state the correct active constituent concentration.

Hazard

This is a printing error on the leaflet only. The product itself has been manufactured correctly and meets all quality and safety standards. The efficacy and safety of the product is unaffected. The dose rate remains unchanged, as per the instructions on the immediate and primary label.

What to do if in possession of this chemical product

Refer to the immediate label (bottle) and primary label (carton) for the correct active constituent concentration. Affected customers will be contacted.

On 10 July 2025, ADAMA Australia Pty Ltd (ACN 050 328 973) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

Reason for voluntary recall

The presence of crystals following extended exposure to cold conditions has been detected in some batches of 20 L LEOPARD 200 Herbicide which may cause handling issues and blockages in application equipment but should not present any crop safety concern.

Hazard

The sediment formed by the crystals may impact the expected performance of LEOPARD 200 Herbicide and may lead to equipment blockages during application.

What to do if in possession of this chemical product

DO NOT use the product if the batch number is 56028, 56029, 56030, 56031, 56297, 56298, 56299, 56300, 56301, 56302, 56303, 56304, 56563, 56625 or 56626. Quarantine unopened or partially used containers of LEOPARD 200 Herbicide from the affected batches and contact ADAMA Australia for instructions for collection and refund.

On 10 July 2025, Bayer CropScience Ltd Pty (ACN, 000 226 022) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

Reason for voluntary recall

An incorrect back label has been affixed on some 10 L containers instead of the current approved label (approval number 63243/132620).

Hazard

The incorrect back label provides Directions for Use for a registered Bayer herbicide product and if followed could result in harm to the crop treated.

What to do if in possession of this chemical product

Quarantine stock which has the incorrect back label, ensure product is stored locked up, and contact Bayer Customer Service or your local supplier for return and replacement stock.
