The *Agricultural and Veterinary Chemical Code Act 1994* (the Act) commenced on 15 March 1995. The Agricultural and Veterinary Chemicals Code (the Agvet Code) scheduled to the Act requires notices to be published in the *Gazette* containing details of the registration of agricultural and veterinary chemical products and other approvals granted by the Australian Pesticides and Veterinary Medicines Authority. The Agvet Code and related legislation also requires certain other notices to be published in the *Gazette*. A reference to Agvet Codes in this publication is a reference to the Agvet Code in each state and territory jurisdiction.

The APVMA Gazette is published fortnightly and contains details of the registration of agricultural and veterinary chemicals products and other approvals granted by the APVMA, notices as required by the Agricultural and Veterinary Chemicals Code (the Agvet Code) and related legislation and a range of regulatory material issued by the APVMA.

Pursuant to section 8J(1) of the Agvet Code, the APVMA has decided that it is unnecessary to publish details of applications made for the purpose of notifying minor variations to registration details. The APVMA will however report notifications activity in quarterly statistical reports.

On 4 August 2025, Pharmachem Australia Pty Ltd (ABN 664 014 644) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the *Agricultural and Veterinary Chemicals Code Act 1994 (Cth)* in relation to the chemical product described above.

Reason for voluntary recall

A typographic error on the sides of the retail carton. The printed text reads 'for small dogs' when it should read 'for large dogs'. All other information on the label is correct.

Hazard

Due to typographic error, the product may be incorrectly used for small dogs.

What to do if in possession of this chemical product

Quarantine stock which has the incorrect label and contact Pharmachem Australia Pty Ltd Customer Service for return and replacement stock.
