The Agricultural and Veterinary Chemical Code Act 1994 (the Act) commenced on 15 March 1995. The Agricultural and Veterinary Chemicals Code (the Agvet Code) scheduled to the Act requires notices to be published in the *Gazette* containing details of the registration of agricultural and veterinary chemical products and other approvals granted by the Australian Pesticides and Veterinary Medicines Authority. The Agvet Code and related legislation also requires certain other notices to be published in the *Gazette*. A reference to Agvet Codes in this publication is a reference to the Agvet Code in each state and territory jurisdiction.

On 16 December 2022, Troy Laboratories Pty Ltd (ACN: 000283769) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

#### Reason for voluntary recall

This batch recall has been initiated due to the incorrect syringe being included with the product.

This product should include a syringe with "kg" markings (i.e., measuring in mg/kg body weight), but instead includes the syringe with normal "mL" markings.

#### Hazard

Use of the incorrect syringe may result in dosing errors.

#### What to do if in possession of this chemical product

If you are in possession of the affected product and you are a veterinarian, please contact the holder to arrange replacement of stock.

If you are an animal owner who has been prescribed this product and have it in your possession, please contact your veterinarian to arrange a replacement and to discuss your pet's treatment as required.
