The APVMA has before it an application for the approval of a new active constituent, cis-Jasmone.

# Summary of the APVMA's evaluation of cis-Jasmone active constituent

The APVMA has evaluated the chemistry aspects of active constituent cis-Jasmone (physico-chemical properties, stability, identification, manufacturing process, quality control procedures, batch analysis results and analytical methods) and found them to be acceptable.

The APVMA has considered the toxicological aspects of cis-Jasmone and concluded that there are no toxicological concerns to the approval of this active constituent. As the proposed products containing cis-Jasmone are currently intended for use only on the soil application, food residues are highly unlikely due to its high volatilisation. An acceptable daily intake (ADI) and acute reference dose (ARfD) have therefore not been established as part of this application.

The Scheduling Delegate made a final decision to include cis-Jasmone in Schedule 6 of the Standard for the Uniform Scheduling of Medicines and Poisons (SUSMP) except when included in Schedule 5, for preparations containing 1.5% or less of cis-Jasmone.

On the basis of the data provided, and the toxicological assessment, it is proposed that the following active constituent standard be established for cis-Jasmone:

Other impurities of toxicological significance are not expected to occur in cis-Jasmone as a result of the raw materials and the synthetic route used.

The APVMA accepts the findings and recommendations of its advisors on these criteria.
