

Summary of the APVMA's evaluation of florlypicoxamid active constituent

The APVMA has evaluated the chemistry aspects of active constituent florlypicoxamid (physico-chemical properties, stability, identification, spectra, manufacturing process, quality control procedures, batch analysis results and analytical methods) and found them to be acceptable.

The APVMA has considered the toxicological aspects of florlypicoxamid and concluded that there are no toxicological concerns regarding the approval of this active constituent. An acceptable daily intake (ADI) for florlypicoxamid was established at 0.1 mg/kg bw/day, while an acute reference dose (ARfD) was not considered necessary. No toxicologically significant impurities have been identified in florlypicoxamid technical active constituent.

The Scheduling Delegate made a final decision to include florlypicoxamid in Appendix B of the SUSMP.

On the basis of the data provided, and the toxicological assessment, it is proposed that the following active constituent standard be established for florlypicoxamid:

Constituent	Level
florlypicoxamid	930 g/kg minimum

Other compounds of toxicological significance are not expected to occur in florlypicoxamid as a result of the raw materials and the synthetic route used.
